
To help offset the costs of the **SCTC** program, riders will be asked to make donations according to the length of each trip. At the end of each trip they will be provided with a stamped envelope addressed to Cayuga/Seneca Community Action Agency (**CSCAA**) in which they may make contributions by cash or check.

It is suggested that **donations** of \$5.00 be made for rides to local destinations, those less than 10 miles one-way. For rides between 10 and 25 miles one-way, a donation of \$10.00 is suggested. For rides more than 25 miles one-way, a donation of \$20.00 - \$30.00 would be appropriate.

Riders must be ambulatory, that is, able to get in and out of vehicles without assistance. No smoking is permitted by either driver or rider during SCTC trips. On the way home, stops may be made to pick up prescriptions or other items needed. The SCTC is pleased to provide this service for those in need of transport.

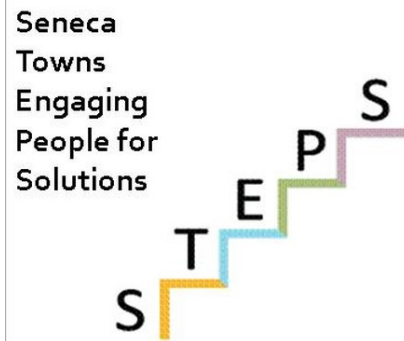
South County Transportation Corps (SCTC)



Providing rides for residents of Covert, Lodi, Ovid, and Romulus to medical and dental appointments and other health-related destinations.

Cayuga/Seneca Community Action Agency (CSCAA) is pleased to sponsor the **South County Transportation Corps (SCTC)**, an innovative program involving volunteer drivers transporting neighbors who need rides to medical and dental appointments or to other health-related destinations.



The program grew out of a Resident Health Promotion Project of **STEPS**, which stands for **Seneca Towns Engaging People for Solutions**. The four towns in the STEPS neighborhood include Covert, Lodi, Ovid, and Romulus. STEPS is a resident health status improvement project of the **Greater Rochester Health Foundation**.



The **Greater Rochester Health Foundation (GRHF)** has awarded a Community Health Grant to support the SCTC pilot program, which commenced July 1, 2016. Among other things, GRHF funding covers the cost of driver background checks and excess automobile liability insurance premiums for the drivers, who have volunteered to use their own vehicles for this service.

The **SCTC** is designed to supplement the **Retired and Senior Volunteer Program (RSVP)** that provides seniors who are 55 years of age or older with transportation to medical and dental appointments. There are no age requirements for SCTC ridership, but individuals under 18 must be accompanied by a parent or a designated adult. The SCTC does **NOT** transport **Medicaid-eligible** residents, because they have service provided by the county and the state.

For health-related transportation, residents who are 55 years of age or older should call the **RSVP** dispatcher at 315-665-0131. Medicaid-eligible citizens should call the Medicaid Answering Service (**MAS**) at 866-753-4437. Other residents of the towns of Covert, Lodi, Ovid, and Romulus should call the dispatcher of the South County Transportation Corps (**SCTC**) at 607-532-4891.



In May 2016, the **Seneca County** Board of Supervisors voted to underwrite the mileage costs of SCTC drivers at the federal rate of 54 cents per mile during calendar year 2016, up to a maximum of \$5,400. Without the support of Seneca County, the SCTC could not function, thus it is hoped that funds will be placed in the County budget for 2017 to enable the program to continue if it proves successful during its first six months of operation.
